## Annual Meeting Procedures

The Annual Meeting is open to members of the League of Women Voters of the Flint Area, their guests and visitors. Only members in good standing are allowed to speak and vote.

Roberts Rules of Order will govern the general conduct of the meeting, except where superseded by the Bylaws or Annual Meeting Rules.

A Parliamentarian shall be selected to:

- 1) Advise on the proper application of the rules,
- 2) Make a ruling when there is conflict regarding the interpretation of a rule, and
- 3) Determine the proper way to conduct the meeting (based on *Robert's Rules of Order*)

The Secretary, or Chair, may request that motions or amendments be put in writing.

A reading committee selected at last year's meeting verified the accuracy of the minutes. Three volunteers will be asked to do the same for this meeting of the membership.

Each year our local program must be approved by the membership. The Board recommends approval of the program as printed in this report. A majority vote of members attending the meeting is needed for approval.

Our Bylaws provide for election of officers and directors. Election of the slate, as presented by the Nominating Committee, is by majority vote. The Nominating Committee consists of two Board members, appointed by the board. All remaining members who are not on the Board are elected at this 2014 Annual Meeting.

## REPORT OF THE BOARD

Programs and advocacy at the local level continue to be busy!

We are working hard to increase our VISIBILITY throughout the Genesee County.

In 2013, Kristal Jackson wrote a strategic plan to improve our communications and visibility through Information Technology as her Master's thesis. Key to the plan was to begin using Constant Contact for our communications. We went from circulating four newsletters per year to (typically) one a month. In total, we have sent out 64 messages since adopting Constant Contact two years ago. We have also gone from just over 200 on our mail list to nearly 600 on our electronic list; six continue to receive messages by mail. Many thanks, to Kristal Jackson, for sharing her expertise with our local League.

### NON-PARTISAN EVENTS

The League works to provide the community with educational information about public issues. Educational and Voter Service events are designed to provide citizens with unbiased, factual information they can use as a basis for reaching their own decisions or as a springboard to advocacy. This year, we held a number of community events; at times we partnered with the Flint Area Public Affairs Forum and the MSU Extension because it broadens our reach without compromising our message.

## NATIONAL CONVENTION

Linda Hoff represented our local League at the National Convention in Dallas, Texas. While at convention, she co-chaired an event on Michigan's Poll Watching activities and co-led a recap discussion on the Agriculture Update. A full report was e-mailed to members in June 2014; if you would like a copy forwarded to you just let us know.

## STATE CONVENTION

We were well represented at the LWVMI Convention: Linda Hoff, Kristal Jackson, Ann Kraft, and Shawntae Harris each attended as delegates. Edith Prunty Spencer was a special guest of the convention, as she received LWVMI's highest recognition, the Belle Brotherton Award, named after the first LWVMI president. Edith was accompanied by Helen Hoyt; both were able to attend Saturday afternoon sessions.

Linda Hoff was elected to serve as the VP of Advocacy and Kristal Jackson was elected to serve as a Director At Large of the Board.

## PROGRAM POSITIONS

Program is the League's reason for being, the basis for both advocacy and educational efforts. Every two years our local League participated in position review activities at the state level in addition to our annual review of local positions. This year, we spent two full days analyzing positions and making recommendations.

### **Review of LWVMI Positions**

Below are comments, observations and suggestions arising from the review conducted by the LWV of the Flint Area.

#### **Election Laws:**

- Consider adding statement relative to disallowing the passing of legislation that interferes with or nullifies the people's vote through referendum.

#### **Intergovernmental Relations:**

- The three paragraphs that specify the LWVUS Principles seem like a good preamble to the whole "Government" section, not just this position.
- A statement along the lines of "protect community long-term resources, especially while under state emergency management" – not sell off assets (to

private enterprises) for short-term gain, that would otherwise provide financial stability to the community over the long term

- Pg 1, Sect II: These sentences are a bit confusing. Would this, as stated, support the concept that *only* State government has the expertise as to whether a local community must allow energy facilities/processes - that the local community does not have the knowledge base to make these decisions? The sentences seem a bit redundant –they need more clarity.
- Pg 2, Sect III, B: there was a request for clarification as to “why” LWVMI does not support direct election to membership in RP&Ds.
- Pg 2, Sect III: there are concerns here about accountability and transparency. As the RP&Ds are 501(c)4 administrative organizations, they are not subject to FOIA and they are not subject to “open meetings.” There was an article by the Metro Times - Detroit Economic bureau relative to the education funds being directed to the new Red Wings hockey arena. Just this week, the action was confirmed as legal by the AG.
- At the end of the position statement, there is a statement in Bold Italics – what is the context of this statement?

## **Taxation and Budgeting:**

- Sect IV does not appear to be up to date

## **Great Lakes Ecosystem:**

- Perhaps add Hydraulic Fracturing and other new methods/technologies as yet to be developed
  - NO exclusions from the Clean Water and Clean Air acts
  - Remove power of Eminent Domain by government bodies for private enterprises
  - Concerns over the legislative removal of power in local communities
- The ecosystem should clearly reference land, water, air and biodiversity as interrelated concerns
- Currently, hydraulic fracturing enterprises are exempted from water withdrawal limits – rules should apply to ALL to protect the precious resource
- The state is currently in negotiations for a land swap in the UP – part of the proposed deal is no survey and the land is sold “as is.” However, if the state decides to mine the swapped land, they must pay a royalty to the private organization. Where’s the oversight?

## **Land Use:**

- Sect III: See first and last bullet above (eminent domain and public lands for sale, swap, or lease)

- Sect III: Voice and power of citizen voice should be protected through committee work and/or vote
- Land and Air quality and interrelationship should be part of the Ecosystem

## **Pesticides:**

- With the myriad of chemical exposures we encounter, this should be retitled and perhaps updated as Chemical Use and Exposure to allow for broader application

## **Solid Waste Management:**

- Title should be updated to Solid Waste and Recycling Management
- Quarterly Toxic and hazardous waste drop offs should be offered in every county

## **CAFOs:**

- People who would be exposed to air, water and land quality issues must get a voice in the planning process. Existing home owners who are negatively affected due to environmental concerns need recourse and compensation.

## **Children and Youth:**

- The first paragraph looks like a preamble. The second looks like it should be item I.
- Sect II: Second sentence, end with “with needs that differ from adults.”
- Sect II: Judges (or their designee) should remain peripherally involved to ensure that the judge’s orders are abided by and ensure that children inmates are dealt with in a manner appropriate to their age and ability.
- Sect II, B: There should be STRICT limits on the use of solitary confinement that is either for protection or punitive purposes.

## **Social Services:**

- This has not been updated since 1971!
- Opening sentence, plus 1) and 2) should be a preamble to the position.
- Sect I: can we have a State level position that says what we would like/expect to see by the Federal government?
- Sect 1: is it current and relatively realistic
- Sect II: include “and special needs” after low-income.
- Sect III: last sentence add housing before child care
- Perhaps this should get an “update”

## **Health Care:**

- Address full range of reproductive health care services for women – in any institution that receive public funds

## **Prisons in Michigan:**

- Retitle as Criminal Justice and Prisons in Michigan
- Retributive justice – perhaps phrased differently than “punishes.” For many this is an alternative to prison wherein the injurious party must act in a manner that restores balance to the injured party.
- This should more strongly address the problem of “overcriminalization.”
- Subsection under I.C.: when a juvenile must be imprisoned, they should be handled carefully and appropriately according to their age and mental maturity.

## **Libraries:**

- Per three of our librarian members, this position needs to be updated – it is especially outdated with regard to being inclusive of current technology and penal fines that are historically a vital part of library funding.
- There are looming issues on funding of libraries and the distribution of funds
- Cooperatives (local, county) are not working as they used to: book selection, tech services, and interlibrary loans.

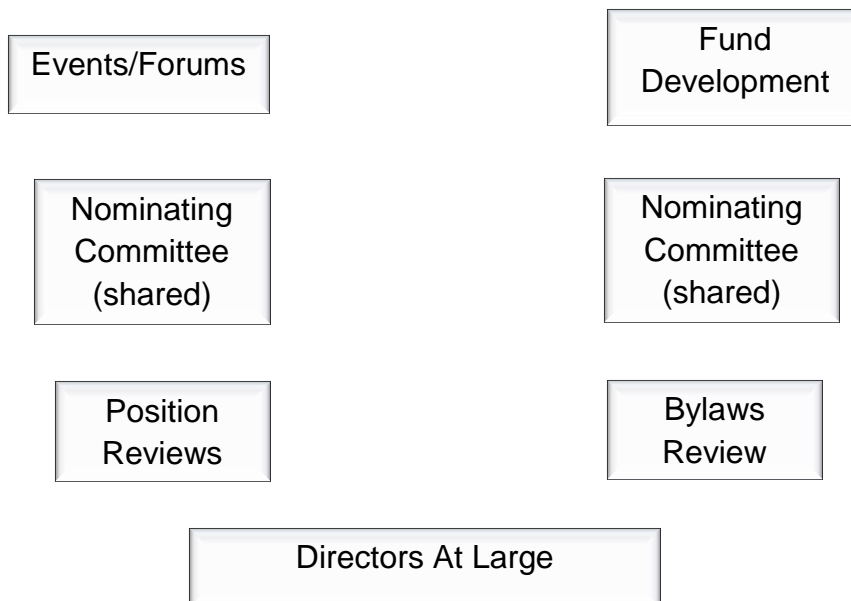
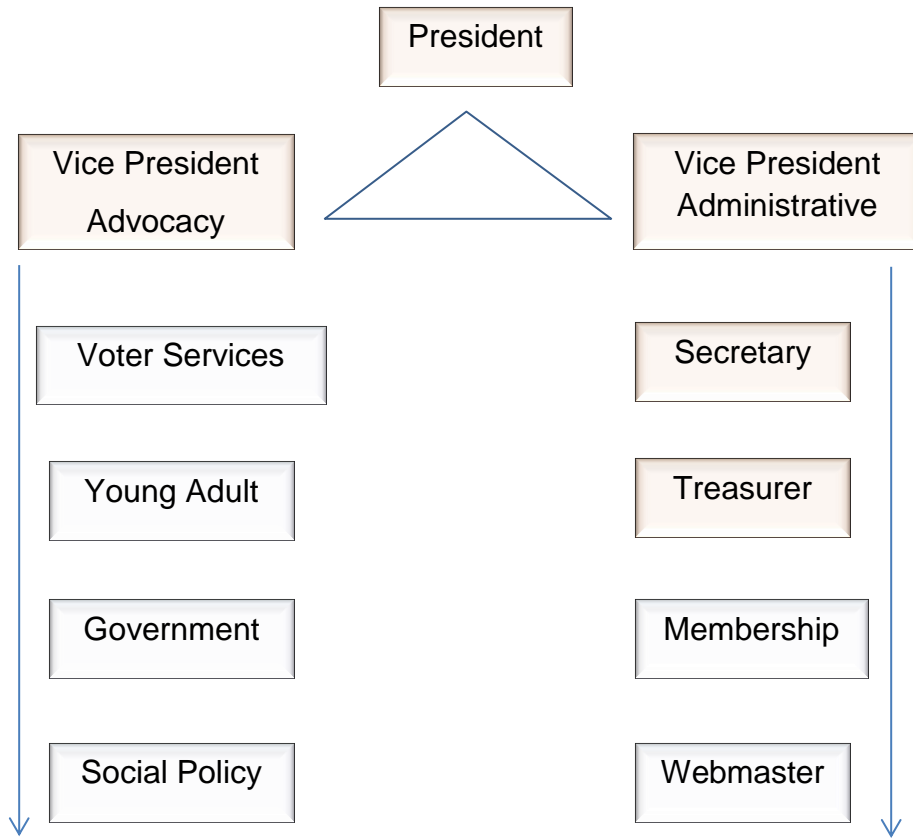
In addition to the above activities, we will remain attentive to local issues that citizens need to be informed.

## LOCAL PROGRAM POSITIONS

Following this year's review of local program positions, the board has recognized that the need likely outweigh the resources to update positions according to the following concerns. The board has approved the request to update the Flint Charter and Housing Relocation positions, with others updated as time and manpower permits:

- Flint Charter: approve update so that we may effectively advocate when the Charter Revision Committee submits a plan
- Housing: this needs an update to accommodate the current housing situation
- Education: needs updates to correlate to the newly updated LWVMI position – This position currently refers only to Flint Public Schools. The update should refer to “Genesee County publicly funded schools.”
- Financing of Flint Schools: primarily housekeeping – again there is interest in re-titling to the more inclusive “Financing of Publicly Funded Genesee County Schools” and adding this topic to the Local Education position
- Genesee County Correctional Facilities: this position needs a 3-fold update – 1) to compare/contrast to the LWVMI position for Prisons; 2) to make reference to female-specific needs; 3) to address issues of Juvenile Detention; and 4) housekeeping measures.

### FLINT CITY CHARTER (Revised 1995)

Support of Charter with the following standards:

- A. Support a strong mayor elected on a non-partisan basis.
- B. Support non-partisan election of council persons.
- C. Support a direct line of responsibility and accountability to be clearly established for all departments, agencies, boards, and commissions for the function of city government.
- D. Support a responsible and accountable financial structure under the jurisdiction of the executive.
- E. Support City Council power to override a mayoral veto by 2/3 vote.
- F. Support a personnel system under the jurisdiction and responsible to the executive with policies consistent with sound personnel procedures, which allows for a grievance commission responsible for employee appeals and accountable to City Council.

### HOUSING RELOCATION (updated 1995)

- A. The League supports efforts to determine the housing needs of the community.
- B. The League supports the assurance to all persons displaced by government actions that there be adequate and appropriate housing available to them prior to

the date of their displacement. The special needs of the poor, the elderly and racial minorities should be recognized.

- C. The League supports (1) notifying persons in a uniform manner of their impending displacement and (2) advising relocates in laymen's terminology of the legal rights and services available to them.
- D. The League supports the wide dissemination of information about a Certificate of Compliance – its role in property transfer, its meaning, how it is secured, and what a Waiver of Certificate means.
- E. The League supports a legislative amendment to the City Ordinance which would require that when a Certificate of Compliance is waived all defects of the property should be listed in layman's terminology and presented to the buyer.
- F. The League supports the offering of personalized services and compensatory housing programs of public agencies to personal being displace by governmental actions; particularly to groups with special housing needs such as the poor, the elderly and racial minorities. Such services might include personal casework, counseling, specific referrals to available and appropriate housing, transportation to inspect prospective dwellings, financial advice and maximum financial aid, and assistance with any other problems involved in making a successful adjustment to relocation. The League supports staffing and funding adequate for public agencies to operate effectively and efficiently.
- G. The League supports periodic independent evaluation of the public agencies concerned with relocation to determine their effectiveness, with the results of these evaluations made public.

## **COUNTY EXECUTIVE** (Adopted 1981)

The League of Women Voters of the Flint Area supports the unified form of county government enabling the electorate to choose between two options of county administration: government with an appointed county manager or with an elected county executive. The administrator is responsible for the overall supervision of all county departments not headed by elected officials and has common powers and duties as spelled out in the law. (P.A. 139 passed in 1973.)

The unified form of county government which would provide for a strong administrative officer would include the following standards:

1. Separation of administrative and legislative role.
2. Provisions of long-range planning for services.
3. Central administrative control over:
  - a. County operations
  - b. County departments
  - c. Boards and commissions
  - d. Non-elective positions

5. There should be adequate and consistent funding for libraries in order to facilitate long-range planning.
6. The materials selection policies of the Flint Public Library and the Genesee District Library should provide for a balanced library collection.
